

**COVID-19 Protocols for Aullwood Summer Programs**  
**Updated as of June 2, 2021**

Beginning June 2, 2021 and in concert with the expiration of the State of Ohio's COVID-19 health orders, the Centers for Disease Control and National Audubon Society/Aullwood Audubon, our summer program COVID-19 policies are as follows:

1. Participant's parent/guardian will sign the National Audubon Society's Liability and Photo Release prior to program.
2. Due to the continued risk of COVID-19 infection in the community, all non-vaccinated staff, volunteers and participants are required to wear a mask while inside any Audubon/Aullwood buildings. Masks are optional outdoors; if unmasked, participants must maintain a 6-foot physical distance.
3. Aullwood Audubon is not requiring COVID-19 vaccination to participate, nor are we collecting personal health information, including vaccination status. Anyone eligible to receive the COVID-19 vaccine is strongly encouraged to do so for the benefit our community.
4. Stay home if you are sick. Staff, volunteers and participants who exhibit potential symptoms of COVID-19 should not come on site under ANY circumstances unless they are symptom-free for 24 hours. This means any volunteer/participant may not return to Aullwood the following day. An alternative would be to go to your physician or health center, ask for a COVID-19 Rapid Test and receive a doctor's note clearing your return to the program. Symptoms include a temperature of 100 degrees, loss of taste/smell, new abnormal cough, trouble breathing, sore throat, chills, nausea, vomiting, headache or body aches.
5. If a participant becomes ill, they will be removed from the program, safely isolated under supervision until a parent/guardian can pick them up. All participants will be notified of potential exposure while respecting the privacy of the ill person.
6. Aullwood Audubon will regularly clean and sanitize areas used by the program.
7. All participants agree to follow the Audubon/Aullwood COVID-19 Code of Conduct:
  - Committing to take care of yourself and others.
  - Minimizing exposure to COVID infections when not attending the program (before and during the program).
  - Staying home when sick, or if exposed to others who may be sick.
  - Agreeing to follow program rules including:
    - a. Mask usage.
    - b. Social distancing.
    - c. Hand-washing (routinely, especially before eating and after using the restroom).
    - d. Any other safety instructions provided by staff.
    - e. Being kind and considerate of other participants, volunteers and staff.
    - f. Asking questions if unclear about any of the rules.
    - g. Not hugging, holding hands or having physical contact with staff or volunteers.
    - h. Following program leader's guidance if providing snacks.
    - i. Bringing your own water bottle with your name on it.
